## Concerns with EMS & Dispatch

- EMS is to inform Dispatch when a truck will be taken out of service. The notification is to be sent to the EMS\_Status ActiveAlert group.
- Request for mutual aid from another county is to simultaneously dispatch EMS and Squads following established protocols.
- Use of "Ops" talk groups was discussed. Mr. Long was to check with Chief Boland. Until a change is made, Squad vehicles will go enroute to the incident and immediately switch to the "Ops" talk group.
- The dispatch of a secondary squad was discussed. Dispatch protocol exists and is to be followed.

## Drug Policy

 Drug Policy was discussed. Mr Long and Mr Andrews will produce a draft change. Concerns were: notification of effected organizations, notifications of system wide suspensions, random testing procedures.

#### Vehicle Return to Service

• When Vehicle Services has completed a repair, the Chief is to be notified to allow equipment to be replaced before the unit is returned to service.

#### Incident Command System

 Mr. Richardson requested the Incident Command procedure be modified regarding when command is passed. Mr. Long was asked to schedule a meeting of the concerned parties to begin this process.

#### Systemwide Training

 The need for system wide training was discussed. Topics include ImageTrend, Search, Palmetto EOC, ActiveAlert

#### Rescue Capacity Needs Assessment

 Mr Richardson presented information from the North Carolina Rescue Association and asked each squad to conduct the inventory as part of a needs assessment. Squads were to complete by October 1, 2022

#### Integration of Fire Departments

 The integration of Fire Departments into the role of the Board of Rescue Squads was discussed.
