Chairman Waldrop called the meeting to order and opened with prayer.

Karen Brehmer informed the Commission of the projects that had been updated since the last meeting. These projects were City of Newberry Recreational Complex, Consolidated Water Points, Fire Training Center, 800 MHz Radio Service, and Silverstreet Demolition. She provided commissioners with the information to place in their binders. A Project Scoring Sheet and a Master Scoring Sheet were provided. The letter from County Council stating its sponsored projects was given to each commissioner.

Mrs. Brehmer informed the Commission on the process used to develop the project presentation schedule. Chairman Waldrop had randomly drawn the project names to determine the presentation date and approximate time. Letters were mailed to all entities concerning this schedule.

Theo DuBose provided an update on available funds. There should be a carry-forward amount of \$3.0 million from the current (2010) CPST iteration. \$18.5 million can be bonded for the upcoming (2016) iteration, along with \$2.0 million to be pledged to the back-end (non-bonded.)

Mr. DuBose informed the Commission of its responsibility to decide whether the projects would be financed by bonding or pay-as-you-go funding. This decision will have to be indicated on the ballot.

Wayne Adams reminded the Commission that a scoring sheet was just a tool to assist the Commission in prioritizing projects. The CPST Act provided broad latitude to the Commission in selecting projects and allocating amounts to projects within available funding limits.

Mr. DuBose spoke regarding conflicts of interest and FOIA. He stated that no County funds could be used to promote the outcome of the referendum. It is the responsibility of the individual to recuse himself/herself if there is a conflict of interest.

Chairman Waldrop reminded the Commission of the future meetings for presentations. Presentation dates are April 4, 11 and 18. On April 25 and May 2, the Commission will meet to deliberate on which projects to include in the referendum question. The Commission must complete its work and forward the ballot list to County Council no later than May 16.

Mr. Adams explained the role of County Council. In order for a referendum to be held in November, County Council must adopt the list of projects recommended by the CPST Commission in the form of an ordinance. This will require three readings and a public hearing. The listing of projects contained in the Ordinance determines the priority. The CPST Commission may send the listing in their prioritized order but County Council has the final decision to accept the Commission's recommended order or to change it. No project can be added or removed by County Council, only the order changed.

Matt Dewitt of City of Newberry asked if the Commission will be asking if a project can be scaled down. Chairman Waldrop advised him to be prepared to make such a scaling recommendation on the City's behalf at the time of its presentation. He also advised the presenters to be ready for questions on cost reductions.

Commissioner Toland stated that she did not like that County Council did not submit all of the projects submitted to it, but she would move forward.

Meeting was adjourned at 6:17PM.

Re: Newberry County Project Proposals

Please find enclosed completed submission applications for five (5) projects selected by Newberry County Council for proposed inclusion in the November 2016 capital project sales tax (CPST) referendum question.

On Wednesday, March 9, 2016, County Council scored and ranked all nine (9) proposals submitted to it, and determined that it would forward only those listed below to the CPST Commission. They are listed in order of priority, along with brief descriptions and corresponding requested amounts.

1. 800 MHz Emergency Services Radio System -- \$7,400,000

Upgrades all emergency services radio systems in Newberry County to statewide SC Palmetto 800 radio system.

2. Detention Center Repairs/Improvements -- \$3,300,700

Makes repairs required by the SC Department of Corrections and adds space for additional detainees.

3. Consolidated Fire District Water Supply Improvements -- \$1,100,000

Provides for ten (10) underground water storage tanks (40,000 gallons each) at various locations to provide water for firefighting.

4. Emergency Services Fire Training Complex -- \$5,785,000*

Would jointly house a City of Newberry fire station, a County fire station, and County Haz Mat, as well as an emergency services training facility. *An additional \$925,000 (total of \$6,710,000) would provide a burn tower and other improvements.

5. Newberry Museum -- \$3,711,000

Converts the County's former Library (also former post office) to use as a Museum.

As required by the CPST Commission, each of these projects will make comprehensive presentations on dates to be determined by the Commission. The descriptions above are merely for quick reference. Specific cost information on each of these projects is also provided. Please do not hesitate to ask for whatever additional information the Commission may desire.

On behalf of Newberry County Council, thank you for considering these project proposals for inclusion in the 2016 CPST referendum question. Please also express County Council's sincere appreciation for the hard work you and the Commission are doing to decide which projects will best serve the citizens of Newberry County.
