The Newberry County Registration and Elections Commissioners met on Monday, March 5, 2018 at 1:00 pm at the Newberry County Registration and Election Office.

Chairman Henry Summer called the meeting to order and John Glasgow gave the invocation.

Commissioners present were: Chairman Henry Summer, Donnie Bobb, Brenda Fulmer, John Glasgow, Doretha Simpson, Sam Price and Martha Waller. Director Shanna Proctor was also in attendance.

Martha Waller made the motion to approve the minutes of the February 5, 2018 board meeting. John Glasgow seconded. The minutes were approved as written.

Status of moving various precincts:

Midway: The Pastor for Oak Grove Presbyterian Church called and stated the contract as discussed was too much and unnecessary to them. The county requires the contract before paying the required fee for use of the church. The Board discussed pros and cons of both sides before asking Director Proctor to speak to Mr. Cromer and Mr. Martin about consolidating the Midway precinct with either Little Mountain or one of the Prosperity precincts.

Prosperity: The bill for splitting Prosperity precinct into two separate precincts has passed both chambers and been ratified.

Wheeland: Brenda Fulmer spoke with the Chair of the Council for Mt. Tabor Lutheran Church, the Council approved use of the church for the Wheeland precinct.

Director Proctor will send cards out to voters whose precincts or polling locations have changed prior to the June Primary.

Director Proctor informed the Board that Ward 5 had terminated our use of its facility as a polling location. She will send a letter to West End Baptist Church and Westview Behavioral requesting the use of their facilities for polling locations.

All voting equipment has received preventive maintenance. Supplies for voting equipment have been ordered in preparation for the upcoming elections. Filing notices were run, candidate filing opens March 16 and ends March 30.

Mr. Summer reminded everyone to file their Statement of Economic Interests Form by March 31, 2018.

Brenda Fulmer and Doretha Simpson gave an update on the 2018 SCARE Conference. The conference in 2019 will be held February 5-9, 2019 at the Embassy Suites Kingston Plantation.

There being no further business, Doretha Simpson made the motion to adjourn. Brenda Fulmer seconded. The meeting adjourned at 1:35 PM. The next scheduled meeting will be Monday, April 2, 2018 at 1:00 pm.
