The County of Newberry Recreation Department, the Town of Prosperity, and the Newberry County Family YMCA are offering a summer option for baseball and softball. The summer league is a great way to gain additional experience while having FUN! This league is an INSTRUCTIONAL league.

Players will attend a player evaluation and coaches will make selections. Teams will practice for two to three weeks with an eight-game season to follow. Games begin after July 4<sup>th</sup> & will be played in Prosperity.

**Ages 7-9**

(All 7, 8, & 9-year-olds who will be 8, 9, & 10 by April 30, 2023 & who are considering competitive (kids pitch) baseball/softball in Spring 2023)

**Ages 10-12**

(All 10, 11, & 12-year-olds who will be 11, 12, & 13 by April 30, 2023; this age group will ONLY form if enough players sign up to make teams)

**Registration Fee: \$45 (includes jersey and hat)**

Checks should be made payable to Newberry County Family YMCA. Registration can be completed at the Prosperity Town Hall or the Newberry County Family YMCA.
